SUBJECT: Foreign Disclosure Advisory 45 - Revalidation of Disclosure Guidance  
Documented in Air Force Foreign Disclosure Advisories

The purpose of this advisory is to revalidate foreign disclosure and technology transfer guidance previously disseminated in USAF foreign disclosure advisories. This action is important to ensure these policies remain in effect while the revision to AFI 16-201, *Disclosure of Military Information to Foreign Governments and International Organizations*, continues.

SAF/IAPD has disseminated 18 disclosure advisories since 1996 related to a variety of issues, i.e., implementing policy changes, internal USAF business practices, visit process improvements, etc. We are currently working to incorporate the guidance in the advisories into the revised AFI 16-201. Until that time, be advised that advisories 1-26 and 33B have expired. A list of current advisories is attached. The guidance found in the advisories on the attached list is current, and disclosure officers should continue implementation.
