SUBJECT: Provision of Civilian Police-Related Training at the Federal Law Enforcement Training Center (FLETC) (DSCA I-03/017377-P2) (SAF/IAPX #04006)

The attached DSCA memorandum provides guidance with respect to the provision of civilian police-related training, such as the Criminal Investigation Training Program (CITP), to international military students (IMS) under security assistance sponsorship.

Requests for civilian police-related training must be forwarded to the DSCA country desk officer for approval by DSCA and the State Department on a case-by-case basis. When this training is approved under FMS or IMET program sponsorship, the training must be identified as police-related training by AFSAT and the SAO is required to obtain country certification for the IMS in accordance with C10.6.6.7 of DoD 5105.38-M.

DSCA has reviewed SAF/IA's request to provide the Federal Law Enforcement Training Center's (FLETC) Criminal Investigate Training Program (CITP) in conjunction with Air Force Office of Special Investigation (AFOSI) training (as a prerequisite).

Approval for international military students (IMS) to attend the FLETC CITP may be granted on a case-by-case basis. In accordance with the Security Assistance Management Manual (SAMM), paragraph C.4.4.3.5, DSCA and State Department must approve each IMS requirement for this training. Requests for IMS to attend the FLETC CITP shall be submitted to the DSCA country program director, who will coordinate the request with State Department. Certification of IMS in accordance with paragraph C10.6.6.7 of the SAMM is required for attendants of the FLETC CITP.
